

RULES AND REGULATIONS.

 NAME: -(1) The Society shall be called THE SOCIETY OF ST.JOSEPH.

H.REGISTERED OFFICE:

(2) Its registered office will be at St. Joseph's Convent, Cleveland Town, Bangalore.

III. GOVERNING BODY: -

- (3) The Governing Body of the Society shall consist of the President, Secretary and not less than five and not more than seven members elected at the annual general meeting of the Society.
- (4) The members of the Governing Body shall be elected from among the members of the Congregation of -St. Joseph's Convent who shall form the members of the Society. The member must have attained the age of majority.
- (5) The President shall be elected from among the members of the Governing Body who shall hold tenure till the next annual general body meeting. In his absence and in his inability to act as such due to any other cause, the said President shall nominate one of the members of the Governing Body to act as President, and the said acting President shall have all the powers of the President.
- (6) In the event of any vacancy arising from among the members of the Governing Body by resignation or death such vacancy shall be filled by cooption by the Governing Body within three months from the date of such vacancy.
- (7) Once every year the General Meeting of the menbers of the society shall be held. At each such
 meeting ten members shall form the quorum and the
 President shall be entitled to preside over the
 meeting or in his absence any person nominated
 by the President. The President shall be entitled
 to exercise his casting vote when the votes cast
 at the meeting for and against a proposition are
 equal. Within fifteen days after the meeting a
 list shall be filed with the Registrar of Societies,
 the names, addresses and occupations of the members of the Governing Body entrusted with the
 management of the affairs of the Society. At the
 meeting of the Governing Body the quorum shall be

three. It, at the General meeting the meeting of the Governing body there is no quorum, the meeting shall would also treed to A date Taxed by the President my communicated to the members. At such adjoined meeting no growum shall be required.

(8) All the properties both moveable and immoveable belonging to the society shall vest in the Governing Body of the society and all properties to be hereafter acquired or received as gifts in pursuance of the objects of the society shall be acquired in the name of the society. The members of the Governing Body shall only be trustees and will not by any means be the individual owners of the properties of the society.

IV. POWERS OF THE GOVERNING BODY:

- (9) Except as hereinefter provided, the administration, management and all the business relating to the esciety shall be carried on by the Governing Body. The Governing Body shall also do and carry out all other sots and deeds conducive to the attainment of the objects of the society.
- (10) All properties now belonging to the society or hereafter to be established in furtherance of the objects of the society shall be under the control guidance and supervision of the Governing Body.
- (11) The society may and it hereby entitled from time to time at their discretion, to borrow or secure the payment of grant from Government or any other person or public body any sum or sums of money for the purpose of the society and for that purpose to sell, mortgage, charge and deal with the whole or, any part of the asets of the society in such menner and upon such terms and conditions as they think fit and in particular by mortgage, by creating charge on other immoveable properties of the society.
- (12) All documents relating to the properties or to any loans secured by the society as aforesaid shall be executed for and on behalf of the society by the President and the secretary of the society.
- (13) All communications and correspondences with the society shall be addressed to the Secretary. The Society of St. Joseph, St. Joseph's Convent, Cleveland Town, Bangalore.
- (14) The of ficial year shall be Calendar-year.
- (15) The working hours of the society shall be between 9.a.m. to 12 noon and 3 p.m. to 5 p.m. or as directed by the Governing Body.
- (16) Any change in the name or rules of the society shall be made according to sections 9 and 10 of the Mysore Societies Registration Act 1960.

(17) The annual returns of the Society will be field with the Registrar of Societies as her Sall of the Mysore Societies Registration Act 12 160000

V. DISSOLUTION: -

(18) If, upon dissolution of the Society there shall remain after satisfaction of all debts and liabilities any property whatsoever the same shall be dealt with in accordance with the provisions of Sn. 23 of the Mysore Societies Registration Act, of 1960.


